You may wish to seek legal advice concerning the Plan and your classification and treatment under the Plan. If you hold claims or equity interests in more than one class, you will receive a ballot for each class in which you are entitled to vote.

To have your vote counted, you must complete and submit a ballot using CM/ECF for those users with a login and password. For those without a login in and password, you may submit your ballot through the Chapter 11 eBallots Link on the Court's website or by mailing a completed ballot to the Clerk at the address below.
